### What Are CPDUs?

CPDU stands for Continuing Professional Development Units. In order to keep a teaching license active, educators must complete professional development hours and submit them to ISBE.

### The Role of Arts Orgs & CPDUs

As you likely know, the majority of PD available for teachers is not in the arts. Arts organizations can, and do, play an important role in contributing the strengthening teacher practice.

## **Organizational Capacity**

You will be asked to provide the following:

A description of the procedure the organization will use to ensure original documentation is maintained and shared with Ingenuity and ISBE promptly. (ie. digital documentation, designated administrator, etc.)





## **PD Program Details**

You will be asked to provide the following:

- Concise description of your PD program
  - What is the overarching purpose of this PD?, What will participants learn/take away, and generally speaking how will this be achieved?
- Specific session goals

- Educator learning outcome for each goal



# **Qualifications of Presenter(s)**

- **Demonstrated credentials** in the fields of arts education, educational pedagogy, leadership and advocacy, and/or culture, inclusion, and equity. Credentials may include: professional license, certificate, degree in the area of study, or at least 5 years of experience in the area of study.
- **Resume/CV** for up to 2 Presenter(s) and/or facilitator(s) must have demonstrated credentials in the fields of arts education, educational pedagogy, leadership and advocacy, and/or culture, inclusion, and equity.
- **Description of PROCESS facilitator(s) will use** to develop, implement, and evaluate this adult learning experience (\*Please do not re-state presenter credentials for this answer; focus on HOW and WHAT the facilitator(s) does in order to design, implement, and evaluate PD.)
- Description of the process the organization uses to ensure that facilitator(s) understand and align the PD session(s) goals to the organization's goals, mission, and values? (Ie. scheduled meetings to review and map mission/values to PD goals and outcomes)



## **Standards Alignment**

Alignment can be broadly defined as the degree to which the components of an education system—such as standards, curricula, assessments, and instruction—work together to achieve desired goals.

- B) the CPS Framework for Teaching
- C) the Arts Partner Standards of Practice





## **Learning Forward Standards**

#### Learning Communities

Professional learning that increases educator effectiveness and results for all students occurs within learning communities committed to continuous improvement, collective responsibility, and goal alignment.

#### Resources



Professional learning that increases educator effectiveness and results for all students requires prioritizing, monitoring, and coordinating resources for educator learning.

#### Learning Designs

Professional learning that increases educator effectiveness and results for all students integrates theories, research, and models of human learning to achieve its intended outcomes.

#### Outcomes



Professional learning that increases educator effectiveness and results for all students aligns its outcomes with educator performance and student curriculum standards.

#### Leadership



Professional learning that increases educator effectiveness and results for all students requires skillful leaders who develop capacity, advocate, and create support systems for professional learning.

#### Data



Professional learning that increases educator effectiveness and results for all students uses a variety of sources and types of student, educator, and system data to plan, assess, and evaluate professional learning.

#### Implementation



Professional learning that increases educator effectiveness and results for all students applies research on change and sustains support for implementation of professional learning for long term change.



## **Alignment Tips**

**Red Flag 1: Too Many Standards**More standards ≠ necessarily mean better

**Proceeding 2: Far-fetched Standards** Choose standards that your PD directly support standards, curricula, assessments, and instruction (Are you honestly delivering a PD that uses a variety of sources and types of student, educator, and system data to plan, assess, and evaluate professional learning?)





### Educator & Student Growth Impact

You will be asked to provide the following:

Narrative response of how you will determine the impact of the PD on both educator and student growth in regard to **one or more** of the following:

A) content knowledge or skills, or bothB) educator and student social emotional growthC) alignment to CPS or specific schoolimprovement plans

## **ISBE Activity Matrix**

- Event name
- Target audience
- Learning Forward Standards
- Relevant IL Learning Standards and/or Teaching Standards addressed
- Expected impact on student or educator growth or school improvement
- Activity purposes (from ISBE)
